**SKI EDUCATION PROGRAM AGREEMENT AND RELEASE FROM LIABILITY
PLEASE READ CAREFULLY BEFORE SIGNING**

In consideration for the use of this equipment and to ski at Snowbowl, I understand and agree to the following:

1. I accept for use **AS IS** the equipment listed on this form, and accept full responsibility for the care of the equipment while it is in my possession. I will be responsible for the replacement at full retail value of any equipment rented under this form but not returned to the Snowbowl rental shop by the agreed date.
2. I agree to reimburse and hold harmless Snowbowl as well as the manufacturers and distributors of this equipment, for any loss or damage, including any that results from claim for personal injury or property damage related to the use of this equipment.
3. I agree to return to the Snowbowl rental shop, all rental equipment within 30 minutes after the lifts close on the agreed date in clean condition to avoid \$5 late fee or other additional charges.
4. I understand that skiing is a hazardous sport performed where there are many natural and man-made **hazards** as well as environmental conditions which in combination with skiing and/or other skier's actions (i.e. collisions) can result in severe or even fatal injuries. I am aware and understand the **inherent risks** and the requirements for skiers written in the Montana Skiers Responsibility Act (23-7-236 MCA) and the Skier Responsibility Code (both posted at Snowbowl).
5. I understand that the **ski-boot-binding** system will not release at all times or under all circumstances where release may prevent injury, nor is it possible to predict every situation in which it will release, and it is, therefore, no guarantee of my safety.
6. I am aware that my child may be riding the lift alone.
7. I understand that in Snowboarding, Telemark Skiing, and other snow sports utilizing non-release bindings, the bindings will *not* ordinarily release during use, these bindings are not designed to release as a result of forces generated during ordinary operation, and they are absolutely no guarantee to my safety.
8. On behalf of myself and all others named on this form including any minor children, I hereby release Snowbowl, its agents, employees, and the equipment manufacturers and their agents from any and all liability for damage or personal injury to myself and all others named on this form, accepting myself the full responsibility for any and all such damage and personal injury that may result directly or indirectly from the use of this equipment or skiing.
9. I have made no misrepresentation to the ski shop in regard to the height, weight, or age or skier type of the above named skier.
10. I will verify that the visual indicators on my ski bindings correspond to the settings as shown on this rental form.
11. I will not use any of the equipment provided to me until I have received instruction on its use and I fully understand its use and function.
