





REFUND POLICY

1. Dropping class *before* the first session at Snowbowl-Snowbowl course fee less \$10 registration fee
2. Dropping class *before* the third session at Snowbowl-Snowbowl course fee less \$10 plus a prorated amount based on the number of sessions that have occurred at Snowbowl
3. Dropping after the third session at Snowbowl-no refunds
4. Classes cancelled due to inadequate class size-complete refund
5. Rental refunds are prorated based on days used less \$10 set up fee (full refund if class is dropped before first session at Snowbowl).

Minimum enrollment for each class is 6 students. If minimum size is not meet we will try to combine classes (ability and/or disciplines based on instructor qualifications) instead of canceling that class. In that case participants will have option of continuing or dropping class.

Attendance will be taken at each class session. Minimum attendance required by the University is required to pass course.

Bus departs the University at 12:00 noon each day the class meets at Snowbowl.
